STEP 1

In 450 words or less, please describe why you are nominating the Nominee and why they are deserving of a Sage Award.

How has the Nominee, since reaching the age of 60, demonstrated the following attributes?

- *Leadership*
- *Passion*
- *Determination*
- *Creativity*

Please provide examples that relate to the nomination category that is most representative of the Nominee's accomplishments and contributions.

Describe how the Nominee exemplifies the important and valuable role older adults play in our community.

Include reference to any public recognition received by the Nominee in their senior years.

STEP 2

Please include a maximum one-page biography of the Nominee prior to the age of 60. This may include an overview of the Nominee's personal history, education, employment background, past & present affiliations with groups and/or organizations.

STEP 3

Please include one additional letter of support. The letter should come from a person who knows the Nominee's accomplishments well. They should point to the Nominee's specific accomplishments, indicating how they demonstrate the Nominee's qualifications for the Award.

The letter should be a maximum of one page, should speak to the individual's contributions and accomplishments after the age of 60, and must include the writer's contact information.

Submission Format

Please do not use staples, binders, protector sheets or page dividers.

All nomination documentation must be submitted in hard copy or emailed to jlparenteau@mysage.ca by February 20th, 2017.

Nomination form must be signed by the Nominee.

Please provide a good quality photo of the Nominee, if possible, in digital form (jpeg preferred) by email to jlparenteau@mysage.ca. This allows for Sage to better recognize all Nominees at the Awards celebration.

Deadline for nominations is February 20th, 2017. The Awards will be presented at a luncheon celebration to be held on May 10th, 2017 at The Chateau Lacombe in Edmonton.

All Nominees will receive a complimentary ticket to attend the Awards celebration and Award Recipients will receive two complimentary tickets. Nominations of couples/groups is permitted, however the complimentary ticket guidelines remain unchanged. One Award per category will be presented; therefore not all Nominees will receive an Award. However, Sage endeavors to ensure that being nominated for a Sage Award is an outstanding experience for all involved.
