## WHAT TO DO WHEN SOMEONE DIES: A CHECK LIST

When someone dies there are a number of agencies, businesses, and government departments you may need to contact to let them know the person is deceased. Even if the deceased person was considered to be low income, many of the following resources need to be contacted and informed of the date of death.

### Who should do the work?

- Are you the legal representative? Yes if:
  - You are named as the executor in the will;
  - You are appointed as the administrator of the estate by a court; or
  - You are the liquidator for an estate in Québec;
- If you are not a legal representative, the responsibility goes to a surviving family member, in order of priority:
  - spouse, child, child's parent, sibling, grandchild, nephew or niece, other relative solely remaining after deceased.

### Who to contact AFTER someone dies

#### INCOME TAX

What should you do first?

- Inform **Canada Revenue Agency (CRA)** of a death at 1.800.959.8281
  - More information is available on the CRA website [www.cra.gc.ca](http://www.cra.gc.ca) and the guide RC4111, What to Do Following a Death
- Arrangements must be made with CRA if the deceased was receiving the following benefits: Goods and Services Tax Credit (GSTC); Canada Child Benefit (CCB) for a child; Working Income Tax Benefit (WITB) for a child.
  - Arrangements should be made with CRA to transfer benefits.
- The legal representative or surviving family member has responsibilities under the Income Tax Act, and may need information from the deceased person's tax records. The information can be obtained by providing CRA with a copy of the deceased's death certificate, social insurance number and a complete copy of the will, or another legal document, such as a grant of probate or letters of administration showing that you are the legal representative. The legal representative's address is also needed for all correspondence with the tax service centre.
  - You may wish to appoint an authorized representative to deal with the CRA for tax matters on your behalf. You may do so by completing Form T1013, Authorizing or Cancelling a Representative.
  - Death outside of Canada – contact the Canadian Consulate Office for assistance.

## INSURANCE

- ❑ If you are not able to identify the source company of an insurance policy or cannot find the policy or policies of the deceased, the organization below may be able to assist in having a policy search conducted to locate any life insurance coverage that may have been misplaced over time.

- Alberta's funeral benefit ensures deceased persons are given a proper burial or cremation when their estate or responsible survivors are unable to pay for funeral services.

## CREDIT CARDS

These should be cancelled with the credit card issuers and the cards should be destroyed (unless they are in the survivor's name as well).

## BANKS/SAFETY DEPOSIT BOXES

The executor and/or the survivor needs to notify the bank and arrange closing of accounts or updating of names on accounts.

The bank will require a copy of the will & the funeral director's death certificate.

If cheques were deposited directly into a bank account, the issuers may not have the correct address of the deceased and must be informed about the person's death.

- Notify Alberta Health when an individual on your Alberta Health Care Insurance Plan (AHCIP) account is deceased.
- Alberta Health will cancel the coverage for the deceased person and ensure AHCIP coverage remains in place for any surviving family members.

## TELEPHONE

If the survivor is a widow and feels it is necessary for her confidence or safety, the telephone may be retained in the husband's name or she may wish to use her initials.

**VEHICLE**

❑ If a vehicle was registered in the name of the deceased, contact the **Service Alberta Contact Centre** at 780.427.7013.

Parking placards may be cancelled at any Registries office.

❑ Ensure that the name of the deceased is removed from any car insurance policies by contacting the insurance company.

❑ The driver's license or identification card of the deceased should be taken to your local Registries agent, together with a copy of the death certificate or a Funeral Director's statement.

**ESTATE**

❑ The survivor should notify the executor who will arrange for the will to be processed.

❑ If probate is needed, the executor will arrange with a lawyer for this to be done, but the survivor should gather all the necessary papers/documents together including the will.

**DEATH CERTIFICATE**

❑ All of the above actions require proof of death. The funeral home will provide you with a free death certificate that will be acceptable in most circumstances.

**Work closely with the Executor, who may undertake most of these tasks.**
